All payments of said rentals to be made at the Central National Bank of Tulsa Oklahoma, by depositing the same to the credit of the said party of the first part, or by paying the same to the said first party in persos .

The party of the second part shall have the right to remove at any time, from said premises any and all fixtures, appliances and machinery placed the reon by or belonging tosaid record party .
