Now on this 27 th day of August 1908 coming on to be heard the petition of W.T.Brady Guardian of Ruth T Brady and Henry T Brady, minors, and it appearing to the Court that he as such Guardian, on the 27th day of August 1908 made executed and delivered an oil and gas mining lease to the Highland Oil Company , said lease covering the following described lands belonging to Ruth T Brady, a minor, situated in Tulsa County, State of Oklahoma, to-wit :-

Northwest 7.69 acres of Lot 2 in Section Nineteen ( 19 ) Township Twenty ( 20 ) North, Range Thirteen ( 13 ) East .

And it further appearing that he as such guardian on the 27th day of August 1908 made executed and delived an oil and gas mining lease to the Highland Oil Company of Tulsa, Oklahoma, said lease covering the following described lands belonging to ~~Henry~~ <sup>Henry</sup> T Brady, a minor, situated in Tulsa County State of Oklahoma, to-wit :-

Southwest 7.69 acres of Lot 2 In section Nineteen ( 19 ) Towns hip Twenty ( 20 ) North Range Thirteen ( 13 ) East .

And it further appearing to the satisfaction of the Court from the proof offered that it would be to the best interest of said minor wards that said leases as made by said Guardia n be approved . That said minor wards are to receive One-eighth royalty of all oil produced and saved from the premises and \$ 150 per year <sup>for</sup> ~~from~~ each well so long as gas is sold therefrom off the premises .

That the consideration for said leases was <sup>value</sup> full and adequate and <sup>not</sup> disproportionate to the ~~value~~ of the leases sold ,

It is therefore ordered, adjudged and decreed by the Court that the leases as made by W.T.Brady guardian of Ruth T Brady and Henry T Brady <sup>minors</sup> to the Highland Oil Company , of Tulsa Oklahoma , covering lands above described , be and the same are ereby confirmed, approved and declared valid .
