

under the general order of Court relative to leasing minor lands for oil and gas mining purposes, made, executed and delivered an oil and gas mining lease to the Midland Oil Company of Bartlesville Oklahoma, upon the lease form as prescribed by the Honorable Secretary of the Interior covering the following described lands belonging to Beatrice Tiblow, situated in Tulsa County, State of Oklahoma, to-wit :-

S/2 of the SW/4 of the NE/4 and the NW/4 of the SW/4 of the NE/4 of Section eighty (8) Township Twenty One (21) North, Range Thirteen (13) East / containing thirty (30) acres, more or less.

And it further appearing to the Court that Sam Charley as such Guardian on the 20th day of August 1908 under the general order of Court relative to the leasing of minor lands for oil and gas mining purposes, made, executed and delivered an oil and gas mining lease to the Midland Oil Company of Bartlesville Oklahoma, upon a form known as a Commercial lease, covering the following described land belonging to Beatrice Tiblow a minor, situated in Tulsa County, State of Oklahoma, to-wit :-

SE/4 of the NE/4 and the NE/4 of the SW/4 of the NE/4 of Section Eight (8) Township Twenty One (21) North Range thirteen (13) East containing fifty (50) acres, more or less.

And it further appearing that the leases as above made are to terminate with the minority of the said minor ward, Beatrice Tiblow, to-wit on the 22nd day of December 1915.

And it further appearing to the satisfaction of the Court that from the proof offered, that the leases as made, as aforesaid, are for the best interests of the said minor ward; that the bonus for the same is fair and reasonable for the said lands for oil and gas mining purposes; and that if further appearing that the leases provide for one-eighth (1/8) royalty of all the oil produced and saved from the said premises. That in case gas is found, lessor is to receive \$ 150 per year for each well so long as gas is sold therefrom off the premises.

It is therefore order, adjudged and decreed that the leases be, and the same are, hereby ratified confirmed, approved and declared valid.
