

-----ASSIGNMENT OF LEASE :-----

This Agreement, made and entered into this 24th day of August 1908 by and between E.R. Minshall of Tulsa Oklahoma, first party and R.L. Davidson of Tulsa Oklahoma second party , witnesseth that for and in consideration of the sum of One Dollar , cash in hand paid and other good and valuable considerations, the receipt of which is hereby acknowledged, the first party does, by these presents, assign, transfer and set over unto the second party, an undivided one half interest in and to a certain fifteen year oil and gas mining lease, executed and delivered on August 18th 1908 to the first party, by one B.F. Wood , as guardian for Clarence Boyce a minor on the West half of the North east quarter, and the West half of the south east quarter of Section Twenty , Township Nineteen North, Range eleven East (W 1/2 of N E 1/4 and W 1/2 of S E 1/4 of 20-19-11 in Tulsa County, Oklahoma and an undivided one half interest in all the first party's rights, privileges, titles and interests thereunder .

To have and to hold said undivided one half interest unto him the said R.L. Davidson, his heirs and assigns under the terms and conditions of said lease.

-----A G R E E M E N T :-----

THIS AGREEMENT made and entered into this 28 day of July 1908 by and between J.H. Rogers and L.D. Ladd of Tulsa Oklahoma , parties of the first part, and Harry Tyrell and William F Edwards of Tulsa Oklahoma, parties of the second part.

WITNESSETH : That for and in consideration of the sum of One ( \$ 1.00) dollar and other valuable considerations, the receipt of which is hereby acknowledged . The parties of the first part hereby transfer, assign and convey to the parties of the second part an oil and gas lease on the Northwest 9.47 acres of Lot Two (2) and the southeast ten ( 10) acres of lot Two (2) of Section five (5) and the east half of Lot Two (2) of section six (6) all in Township Twenty North and Range Thirteen East, in Tulsa County, State of Oklahoma, executed on the 25th day of July 1908 by W.O. Dickenson and Stella M Dickenson his wife, in favor of the parties of the first part, for the period of Ten ( 10) years from date and as long thereafter as oil and gas can be produced from said land, which lease is attached hereto and made a part of this agreement .

Parties of the second part agree to comply with and carry out the provisions of said lease and to furnish money to put down one (1) well on said land . It is further agreed and understood that if oil or gas is struck in paying quantities that the parties

fix the
