-----: OIL AND GAS LEASE :-----

THIS AGREEMENT Made this 11th day of August A.D. 1908 by and between Thomas Murphy as guardian of Jesse Murphy , a minor, of the first part, and The Iron Mountain Oil Company of Lima Ohio of the second part,

WITNESSETH: That the said party of the first part for One Dollar and other good and valuable considerations, the receipt whereof is hereby acknowledged, and in further consideration of the covenants and agreements hereinafter mentioned has granted, demised leased and let unto the party of the second part, its heirs and assigns, all of the oil and gas in and under that certain tract of land hereinafter described and also all the said tract of land for the purpose and with the exclusive right of drilling and operating for said oil and gas; which said tract of land is situated in the County of Tulsa State of Oklahoma and described as follows, to-wit :

The southeast quarter (I/4) of the North|west quarter (I/4) and the southwest quarter (I/4) of the ~~North~~theast quarter , I/4) of Section Twenty-nine (29) Township Twenty (20) North, Range Thirteen (I3) east , being the allotment of Jesse Murphy , a minor . containing ~~22~~ eighty acres more or less . But no wells shall be drilled within One Hundre d feet of the present buildings except by consent of both parties .

The party of the first part *grants* the further privilege to the party of the second part its heirs and assigns ~~that~~ of using sufficient gas, oil and water from the premises necessary to the operations there ^{on} and all rights and privileges necessary or
