This Indenture of Lease, Made and entered into in quadruplicate on this 19th
day of October A.D. 1908 by and between Charlotte Gonzales, formerly Charlott^e Ghormley of
Stillwell Oklahoma a Full Blood citizen of the Cherokee Nation, part y of the first part,
hereinafter designated as lessor, and John Eaton of Pittsburgh Pennsylvania party of the
second part hereinafter designated as lessee, under and in pursuance of the provisions
of the Act of Congress approved May 27 1908 (Public No 140) (April 26 1906, 34 Stat
L 137) witnesseth :

I . The lessor, for and in consideration of one dollar, the receipt wher eof is
acknowledged , and of the royalties, covenants , stipulations and codstions hereinafter
