WITNESSETH: That the said parties of the first part for One Dollar and other good and valuable condierations, the receipt **xx** where *f* is hereby acknowledged, and infurther consideration of the covenants and agreements hereinafter mentioned have granted demised, 1 leased and let unto the party of the second part, her heirs and assigns all the oil and gas in and under that certain tract of land her inafter described and also all which said tract of land for the purposes and with the exclusive right of drilling and operating for sai oil and gas which said tract of land is situated in the Tulsa County State of Oklahoma, described as follows, to-wit :-
