Witnesseth, that in consideration of the perfromance of the agreement to be performed by each party hereto, as her inafter set out, the parties of the first part have this days and do hereby rent and lease unto the parties of the second part, their heirs and assigns and for agricultural purposes, for the tirm of five (5) years from date hereof, the following described land situated in TulsadCounty, Oklahoma, to-wit :-

Lots I - 2 and 3 of Section I3 and East 7-3/100 acres of lot 1, of Section I4 all in Township I9 North Range 12 and the east one-half of Northeast quarter of Se ction 27 Township I9 North Range I3 East . Same being the allotment of Moses Coney dece ased .
