OIL AND GAS MINING LEASE UPON LAND SELECTED FOR ALLOTMENT
CHEROKEE NATION . OKLAHOM A.

THIS INDENTURE of Lease Made and entered into in quadruplicate on the 8th day of June A.D. 1908 by and between Herman Knight of Needmore Oklahoma a Cherokee citizen of the Cherokee Nation , party of the first part hereinafter designated as lessor, and ~~XXXXXX~~ W.G. Lewis , P.J.White and Thomas White of Tulsa Oklahoma party of the second part hereinafter designated as lessee, under and in pursuance of the provisions of the Act of Congress approved July 1st 1902 32 Stat L 716 witnesset :-

I . The lessor for and in consideration of one dollar, the receipt whereof is acknowledged and of the royalties, covenants , stipulations and conditions hereinafter contained and hereby agreed to be paid , observed and performed by the lessee, does hereby demise, grant, lease and let unto the lessee, for the term of five years from the date of the approval hereby by the Secretary of the Interior and as much longer thereafter as oil or gas is found in paying quantities, all the oil deposits and natural gas in or under the following described tract of land, lying and being within the county of Tulsa and State of Oklahoma to-wit :- The SW/4 of SE/4 of NW/4 and N/2 of SE/4 of NW/4 of Section 19 Township 20 North Range 13 East of the Indian Meridian and containing 30 acres , more or less, with the exclusive right to prospect for, extract, pipe, store and remove oil and natural gas, and to occupy and use so much only of the surface of said land as may reasonably be necessary to carry on the work of prospecting for, extracting, piping, storing and removing such oil and natural gas, also the right to obtain from wells or other sources on said land, by means of pipe lines or otherwise, a sufficient supply of water to carry on said operations, and also the right to use , free of cost, oil and natural gas as fuel so far as necessary to the development and operation of said property .
