

of the Secretary of the Interior it being understood that to secure such approval the proposed assignee need only be qualified to hold such a lease under the rules and regulations and furnish a bond with responsible surety to the satisfaction of the Secretary of the Interior, conditioned for the faithful performance of the covenants and conditions of this lease.

I2. In event restrictions on alienation shall be removed from all the leasehold premises described above, this lease shall be released from the supervision of the Secretary of the Interior, such release to take effect without further agreement, from the date such restrictions are removed and thereupon the authority and power delegated to the Secretary of the Interior as herein provided shall cease and all payments required to be made to the United States Indian Agent shall thereafter be made to lessor or to the then owner of the land; and changes in regulations thereafter made by the Secretary of the Interior applicable to oil and gas leases shall not apply to this lease.

I3. Each and every clause and covenant of this indenture shall extend to the heirs, executors, administrators, successors and lawful assigns of the parties hereto.

I4. In witness whereof, the said parties have hereunto subscribed their names and affixed their seals on the day and year first above mentioned.
