forth, does by these presents demise, lease and rent to said party of the second part,
the following described property, situate in the County of Tulsa State of Oklahoma, to-wit

The N²/₂ I/4 of the Sw I/4 and the NW I/4 of the SE I/4 of the SW I/4 of
Section (23) Township (21) Range (13) East and containing (50) acres more or less .

To have and to hold the same unto the said party of the first part from the first
day of January 1909 to the first day of January 1914 .

And said party of the second part in consideration of the leasing the premises, as
above set forth, covenants and agrees with the said party of the first part, to pay said
party of the first part, his heirs or assigns, as rent for the same the total amount or
sum of Sixty Two & 50/100 (\$ 62.50) Dollars in annual payments, as follows, to-wit :-

Twelve Dollars & 50/100 payable January 1st 1909 or as soon thereafter as
possession is obtained and (\$ 12.50) Payable on or before each succeeding January First
of each year during the life of this lease .

Hereby waiving the benefit of exemption, valuation and appraisement laws of the said
State of Oklahoma, to secure the payment thereof .

The covenants herein shall extend to and be binding up on the heirs, executors
and administrators of the parties to this lease .
