lessee,

WITNESSETH: That the lessors in consideration of One Hundred Dollars, the receipt whereof is hereby acknowledged, being rental in advance for I2 Months from the date he reof, does hereby grant, demise and let unto the said lessels all the oil and gas in a and under the following described tract of land with covenant for the lesses's quiet enjoyment of the term, and the lessors have the right to convey the premises to the said lesses; together with the exclusive right unto the lesses to operate and drill for petroleum and gas, to lay and maintain pipe lines, to erect and maintain telephone and telegraph lines, and buildings covenient for such operations; and the right to use water and gas from said lands im operating same, and right of way over same for any purpose, and right of ingress, egre ss and regress for such purposes, and of removing either during or after the term hereof, any property or improvements placed or erected thereauxing all or any part of all that tract of land situate in the County of Tulsa and State of Okłahoma, and described as follows, to-wit:

S I/2 of SW I/4 of the NW U/4 and E I/2 of E I/2 of NE I/4 of NW I/4 and S I/2 of N I/2 of S W I/4 of N W I/4 (The first described 30 acres being the allotment of Carrie Mc Coy and last IO acres of Waddie Mc Coy) of Section 22 Township 20 Range I3 Containing 40 acres, more or less.

To have and to hold unto and for the use of the lessee for the term of 15 years from the date hereof and as much longer as oil or gas is produced in paying quantities, yielding to the lessor the one eighth part of all the oil produced and saved from the premises, delivered free from expense unto tanks or χ pipe lines to the lessor's credit.

Should a well be found producing gas only then the lessof shall be paid for each such gas well at the rate of \$150.00 Dollars for each year, so long as the gas is sold therefrom, payable quarterly while so marketed.

Lesses agree to complete a well on said premises within Twelve Months from the date ereof, or pay the lessors thereafter the sum of one Dollar per acre per annum, in advance until well is completed or this lease surrendered. And the drilling of such well productive or otherwise, shall be full consideration to lessons for grant made to lesses with exclusive right to drill one or more additional wells on the premises during the term of this lease.

Lessor is to fully use and enjoy said premises for the purpose of tillage, except such parts as my be used by lesses for the purposesaforesaid. Lessee is not to put down any well on the lands hereby leased within ten rods of the buildings now on the said premises without the consent of the lessors in writing. Lessors may if any well or wells on said premises produce sufficient gas have gas for domestic purposes for one family the lessors paying for connection at such points as may be from time to time, designated by lessee.

The above rental shall be paid to lessor in person or by check deposited in postoffice directed to Waddie Mc Coy Mohawk Okla or deposited in the Central National Cox and to the credit of Waddie Mc Coy & Carrie Mc Coy:

And is further acreed that lessee shall have the right to surrender this lease upon
