THIS AGREEMENT : Made and entered into this 1st day of October 1908 by and between Sonney Smith as guardian of the estates of Floyd Smith and Carrie Smith, minors, party of the first part, and S.R.Lewis party of the second part, Witnesseth :-

Said party of the first part for and in consideration of the covenants and agreements to be kept and performed by the party of the second part, hath demised, let and leased unto said party of the second part, for a term of Three (3) years from January 1st 1909 for agricultural purposes, the following described tracts of land located in Tulsa County, State of Oklahoma, to-wit :-

S E 1/4 of NE 1/4 and NE 1/4 of SE 1/4 of Section 29 Township 20 N Range 13 E being the allotment of Floyd Smith , also S E 1/4 of S E 1/4 of Section 29 Township 20 N Range 13 E being the portion of the allotment of Carrie Smith and containing in all 120 acres .

The party of the second part agrees to pay as rental therefor for the full term of this contract , the sum of \$ 220.00 in cash; the sum of \$ 120.00 being in hand paid to the party of the first part at the time of the execution of this agreement, the
