LEASE :--------: OIL A ND GAS

THIS AGREEMENT : Made this 22 nd day of Sept A.D. 1908 by and between Ethel Richmond (Nee) Johnson and cole Richmond her husband of the first part and C.L. Holland of the second part,

WITNESSETH: That the said party of the first part for One Hundred and fifty dollars the receipt whereof is hereby acknowledged and in further consideration of the covenants and agreements hereinafter mentioned has granted, demised, leased and let unto the party of second part, ho heirs and assigns, all the oil and gas in and under that certain tract of land hereinafter described, and also all the said tract of land for the purposeSand with the exclusive right of drilling and mex operating for said oil and gas which said tract of land is situated in Tulsa County, Oklahoma and described as follows, towit :-

N I/2 of N E I/4 Section 29 Township 20 North Range I3 East acres 80 containing 80 eighty acres more or less. But no wells shall be drilled within three Hundred feet of the present buildings , except by mutual consent .

The partys of the first part grants the further privilege to the party of the second part his heirs and assigns of using sufficient water and gas from the premises necessary to the foperation thereon , and all rights and privileges necess ary or convenient for conducting said operations and the rtransportation of oil and gas and the right to remove at any time machinery or fixtures placed on the premises by said lessees .

To have and to hold the same unto the said party of the second part his heirs and assigns for the term of Fifteen years from the date hereof, and as long thereafter as oil or gas is being produced therefrom by said lessees .

In consideration whereof, the said partys of the second part agrees to deliver t o party of the first part in tanks or pipe -lines the eighth part of all oil produced and saved from the leased premises . And should gas be found on said premises in paying · quantities second party agrees to pay One Hundred Dollars yearly in advance for the products of each gas well while the same is being sold off the premises, and first party shall have free use of gas for domistic purposes by making her own connections for such gas at the well at her own risk and expense .
