second party agrees to locate all wells so as C interfere as little as possible with the cultivated portions of the premises and to pay for all damages to growing crops caused by said operations.

Provided, how e ver, that, if a well in not drilled on said premises within one year from date hereof then this lease and agreement shall be null and void, unless the party of the second part within each and every year after the expiration of the time above mention d for the completion of a well, shall pay a rental of fifty cents per acre until a well is completed thereon, or until this lease is cancelled as hereinafter provided.
