And it further appearing to the satisfaction of the Court that the sum paid for said lease as bonus to-wit - \$ 2 per acre is not disproportionate to the value of the proper ty sold, and that it was full and adequate .

And it further appearing that said lease provides for, in addition to the bonus raid a royalty of I2 I/2 % of all the oil produced and saved from the premises and \$ 150 per year for each and every agas well so long as gas is sold therefrom off the premises.

And it further appearing that the said minor child is not financially able to develope mentaxx said lands as leased for oil and gas mining purpoffsed, and that by reason of such developement his estate will be more valuable and productive by reason of the said leasing.

It is therefore, ordered, adjudged and decreed by the Court that the lease, aforesaid, be and the same is hereby ratified, approved, confirmed and declared valid.
