THIS INDENTURE Made the 2nd day of October A.D. 1908 between Buena Vista Rasmus and Bascom P Rasmus , her husband of Tablequah County of Cherokee and State of Oklahoma, lessor and O.M. Lancaster of Tulsa Oklahoma lessee,

WITNESSETH: That the lessor is consideration of One Hundred Twonty (§ 120.00) Dolla's the receipt whereof is hereby acknowledged, being the rental in advance for I2 months from the date hereof, does hereby grant, demise and let unto the saild lessee all the oil and gas in and under the following described tract of land, with covenant for the lesse's quiet enjoyment of the term, and the lessor had the right to convey the premises to the said lessee; together with the exclusive right unto the lessee to operate and drill for petroleum and gas, to lay and maintain pipe lines, provided said lines are such so as not d interfere with cultivation, to erect and maintain telephone and tolograph lines, and buildings convenient for such operations and the right to use water and gas from said lands in operating same, and right of way over same for any purpose, and right of ingress, egress and regress for such purposes, and of removing , either during or at any time after the term hereof, any property or improvements placed or created in or upon said land by said lessees, and the right of subdividing and releasing all or any part of all that tract of land situate in the County of Tulsa and State of Oklahovam and described as follows to-wit :-

North Half of North east quarter of Section (23) Township 20 N Range 13 containing 80 acres more or less , of section "Township" Range containing "acres more or less .

To have and to hold unto and for the use of the lessee for the term of 5 years from the date hereof and as much longer as oil or gas is produced in Paying quantitles, yielding to the lessor the one-eighth ( 1/3) part of all the oil produced and saved from the premises, delivered free from expense into tanks or pipe line s to the lecor's credit. Should a well be found producing gas only, then the lessor shall be paid for each such gap wells at the rate of One Hundred & Fifty Dollars for each year, so long as the gas is sold therefrom, parable quarterly while so marketed.
