Lessor is to fully use and enjoy said premises for the purpose of tillage, except such parts as may be used by lessee for the purposes aforesaid . Lessee is not to put down any well on the lands hereby leased within ten rods of ~~the~~ buildings now on said premises without the consent of the lessor in writing. Lessor may if any well or wells on said premises produce sufficient gas, have gas for domestic purposes for one family, the lessor paying for connections at such points as may be from time to time, designated by lessee .

The above rental shall be paid ^{to} lessor in person or by check deposited in post office directed to ^{or} deposited in the Central National Bank of Tulsa Oklahoma to the credit of Buena Vista Rasmus . And it is further agreed that lessee shall have the right to surrender this lease upon the payment of One Dollar and all amounts due hereunder and thereafter shall be released and discharged from ^{all} payments, obligations, covenants and conditions, herein contained, whereupon this lease shall be null and void and that all conditions, terms and limitations between the parties hereto shall extend to their heirs, successors per sonal representatives and assigns .

Lessor agrees that the recordation of a deed of surrender in the proper County and a deposit of all amounts then due hereunder to lessor 's credit in Central National Bank ~~Bank~~ Tulsa, Bank , shall be and be accepted as full and legal surrender of lessors rights under this lease .
