be made each well within sixty days after commencing to use the gas therrfrom as aforesaid, and to be paid yearly thereafter, while the gas from said wills is so used .

Second party covenants and agrees to ocate all wells so as to interfere as little as possible with the cultivated portions of the premises. And further to complete a well on said premises within one Year from the date hereof, or pay at the rate of Ten and No 100 Dollars quarterly in advance for each additional three months such completion is delayed from the time above mentione for the completion of such well until a well is completed; and is is agreed that the completion of such well shall be and operate as a full liquidation of all rental under this provision during the remainder of the term of this grant . Such payments may be made direct to Jay Johnson or deposited to his credit in Farmers National B Bank og Tulsa Okla .
