The said party of the second part agrees to complete one well within six months from the date hereof (unavoidable accidents and delays excepted), and in case of failure to complete one well within such time, the party of the second part hereby agrees to pay thereafter to the parties of the first part for any further delay the sum of \$100.00, one hundred dollars per quarter as a rental on the same thereafter until a well is completed or the premises abandoned, payable at Central National Bank of Tulsa, Okla. and the parties of the first part hereby agree to accept such sum as full consideration and payment for such yearly delay until one well shall be completed and a failure to complete one well or to make any of such payments within such time and such place as above mentioned renders this lease null and void, and neither party hereto shall be held to any accrued liability, otherwise to be and remain in full force and virtue. It is understood by and between the parties hereto that the terms of this lease shall extend to and be binding upon their heirs, executors, administrators, successors and assigns.

AND I, ANNA WOOD, WIFE OF SAID LESSOR, IN CONSIDERATION OF THE FOREGOING PROMISES, DO HEREBY RELEASE AND RELINQUISH UNTO THE SAID PARTY OF THE SECOND PART, ALL MY RIGHT OF DOWER AND HOMESTEAD IN AND TO THE ABOVE DESCRIBED PREMISES FOR THE PURPOSES OF THE FOREGOING LEASE/
