In the matter of the estate of Yarner Fox, deceased, full blood Creek Indian Citizen No. 1639.

Order confirming deed of full blood heirs.

And now, to-wit, on this 20th day of October, A. D. 1908, this cause coming on for a hearing in open court upon the petition of Perry McKay for the approval and confirmation by this Court of a certain deed, given by Alice John, who is a full blood Creek Indian Citizen and enrolled by the Commission to the Five Civilized Tribes as Alice Fox, Creek Indian Citizen No. 1640, and Rebecca Berryhill, a full blood Creek Indian Citizen and who was enrolled by the Commission to the Five Civilized Tribes as Rebecca Harry, Creek Indian Citizen No. 1636, as heirs-at-law of YarnerFox, deceased, who was a full blood Creek indian Citizer \_\_\_\_\_\_\_\_, and who was enrolled by the Commission to the Five Science Indian Citizen No. 1639, said deed being dated October 20, 1908 and conveying an undivided two-thirds interest in the land allotted to said decedent, Yarner Fox by said Commission to the Five Civilized Tribes as and for her distributive share of the tribal kands of the Creek (or Muskogee)Nation of Indians, to-wit;

The northeast quarter (NE 1/4) of Section numbered fifteen (15) of Township numbered sixteen (16) North, and of Range numbered thirteen (13) East of the Indian Base and Meridian. as appears by the petition of the said Perry McKee now on file in this cause;

And it further appearing from said petition that the said decedent died on May 15, 1901, within the present confines of Tulsa County, State of Oklahoma;

And that the land conveyed by said deed is lying and situated in Tulsa County, State of Oklahoma, and that this Court has full and complete jurisdiction of both the estate of said decedent and the subject matter mentioned in this petition;

And there appearing before this Court on this day the said Alice John and McCully John, her husband, the said Rebecca Berryhill, and Willie Berryhill, her husband, and Nicey Phillips, a Creek Indian Citizen as interpreter for the said Alice John, Rebecca Berryhill, McCully John and Willie Berryhill, who all being duly sworn to testify in this matter, were duly examined by the Court all and singular regarding the premises;

The Court finds from their testimony that the said Yarner Fox died within the present confines of Tulsa County, State of Oklahoma, intestate, on May 15, 1901 at the age of nine (9) years, leaving, surviving her her mother, Nellie Fox, who was a full flood Creek Indian Citizen and enrolled by the Commission to the Five Civilized Tribes as Creek Indian Citizen No. 1637;

And that the said Yarner Fox died seized of an estate of inheritance in fee simple in and to the

Northeast quarter (NE 1/4) of Section numbered fifteen (15) of Township numbered sixteen (16) North, and of Range numbered thirteen (13) East of the Indian Base and Meridian. which was her allotment as a Creek Indian Citizen as aforesaid, and that by the laws of descent and distribution then in force affecting the Tribal lands in Indian Territory, the title to the land above described upon the demise of the said Yarner Fox, vested in her mother, Nellie Fox, Creek Indian Citizen No. 1637 aforesaid;
