AGREPMENT, Made and entered into the IOth day of August A.D. 1908 by and between Ben Brown guardian of Lottie Brown, a minor, of Gatesvalle OklahoMa, party of the first part and Knox M Rowe of Broken Arrow, Oklahoma party of the second part,

WITNESSETH: that the said party of the first part for and in consideration of the sum of \$160.00 Dollar to in hand paid well and truly paid by the said party of the second part, the receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained on the part of the party of the second part, to be paid, kept and performed, has granted and conveyed, and by these presents does grant and convey into the said party of the second part, his successors or assigns, for the sole and only purpose of mining and operating for oil and gas and of laying pipe lines and of building tanks, stations and structures thereon to take care of the said products, all that certain tract of land situate in Tulpsa County, Oklahoma, to-wit:-
