AN ORDER CONFIRMING SALE OF REAL ESTATE.

IN THE COUNTY COURT.

In the matter of the estate of John Walker, minor, an order having been made by this Court on the 23rd day of September A. D. 1908 authorizing L. W. Marks as the Guardian of the property of John Walker, Minor, to sell certain real estate belonging to the said estate, and afterward, to-wit, on the 26th day of October 1908 having made to this Court and filed in the office thereof, a return of his proceedings under the said order of sale, and duly returned to this Court on account of Sales, verified by affidavit his return showing the appraisment and sale after due and legal notice in accordance with the order aforesaid.
