This agricultural lease made and entered into this 3rd day of
September 1908 by and between Hattie Sarty, nee Childers and Herbert Sarty, her husband,
of Broken Arrow, Oklahoma, parties of the first part and the Broken Arrow Loan & Investment
Company of Broken Arrow Oklahoma, party of the second part :-

WITNESSETH: That the said parties of the first part for and in considera-
tion of the covenants of the party of the second part hereinafter set- fourth do by
these presents lease to the party of the second part, and its assigns for agricultural pu-
rposes the following described tract of land locate in Tulsa County State of Oklahoma, to-
wit :-

The south-west quarter (1/4) and the West one-half of the south-east (1/4)
of section 8 Township 18, North Range 14 East containing 240 acres more or less, 160 acres
of said land being the allotment of Robert Childers, deceased, former husband of Hattie
Childers .

It is hereby understood and agreed that this lease shall extend for a
period of one year, beginning January 1 1909 and ending January 1 1910

The party of the second part in consideration of said premises as
above set forth covenants and agrees with the parties of the first part to pay said
parties of the first part as rental for the above described premises, the sum of \$ 200 payable
as follows , to-wit : the sum of \$ 100 in cash, paid September 3 1908 the receipt
