## FARM LEASE/

THIS AGREEMENT, Made this 29th, day of October, 1908 by and between Susie Harjo, party of the first part, and H. E. Whitehead, party of the second part,

WITNESSETH: That for and in consideration of the covenants and agreements hereinafter made; the party of the first part has let, leased and demised and does by these presents let, lease and demise unto the party of the second part, for agricultural purposes, for the term of five years from and after the 29th, day of October, 1908, the following described tracts of land lying in Tulsa County, Oklahoma, to wit:

The said party of the second part agrees to pay to the said party of the first part for the use of said premises, the sum of Twenty Five dollars annually, and the said party of the first part hereby acknowledges the receipt of Twenty Five Dollars for the first year.

THIS LEASE, Made this 0 day of 0 19 0 by Betsy Bolyn, of Cookson, Okla, of the first part to James D. Ward, of Collinsville, Okla, of the second part,

WITNESSETH: That the said party of the first part, in consideration of the rents, covenants and agreements of the said party of the second part, hereinafter set forth, does by these presents demise, lease and rent to the said party of the second part, the following described property, situate in the County of Tulsa, State of Oklahoma, to wit:

The SW $\frac{1}{4}$  of the SW $\frac{1}{4}$  and the SW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Sec. (25) Town (21) North, Range (15) East of the Indian Base and Meridian, and containing (59-) acres More or less according to the approved Government survey thereof.

TO HAVE AND TO HOLD THE SAME unto the said party of the first part, from the first day of January 1909 to the first day of January 1914.

And the said party of the second part, in consideration of the leasing the premises, as above set forth covenants and agrees with the said party of the first part, to pay to the said party of the first part, her heirs or assigns, as rent for the same the total amount or sum of \$62.50 Sixty Two and 50/100 Dollars/ in annual, payments as follows, to wit:

Twelve Dollars and fifty cents payable January first 1909 or as soon thereafter as possession
