C O N T R A C T.

THIS CONTRACT, Made and entered into in duplicate, on this 17th, day of June, 1908, by and between Herman Knight, of Needmore, Oklahoma, party of the first part, and T. O. Cremin, C. M. Armstrong and James Cremin of Tulsa, Oklahoma, parties of the second part,

WITNESSETH: That the party of the first part being a Cherokee Citizen by Blood and entitled to an allotment in the Cherokee Nation as such citizen, hereby for the consideration of the stipulations and agreements herein contained, agrees to execute and oil and gas mining lease upon the following described land, situated in Tulsa County, in the State of Oklahoma, to wit:

The SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ and the N $\frac{1}{2}$ of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$, all in Section 19, Township 20 North, Range 13 East, containing 30 acres more or less, upon the conditions herein stated.

WHEREAS, Said lands are in a contest proceeding between Herman Knight, the party of the first part herein, and Maudie Waters for Eva Waters, a minor of Westville, Oklahoma; and

WHEREAS, the party of the first part herein, Herman Knight, has heretofore, to wit:- on the 8th, day of June 1908, executed an oil and gas mining lease covering said lands to W. G. Lewis
