RENTAL CONTRACT.

THIS AGREEMENT, Made and entered into on this 23rd, day of October, 1908, by and between Margaret Rentie, guardian of Elvira Rentie, a minor, party of the first part and Elmer Mercer, party of the second part,

WITNESSETH: That for and in consideration of agreements and payments hereinafter mentioned the party of the first part hereby leases to the party of the second part, their heirs and assigns, for agricultural purposes for a term of five years from the date hereof the following described tract of land:-

The North East Quarter of Section Seven, Township Eighteen, Range Fourteen in Tulsa County, Oklahoma, being One Hundred Sixty Acres and the allotment of Elvira Rentie.

It is understood and agreed that party of the second part will with party of the first part a rental of Eleven Hundred Fifty Dollars payable as follows: Two Hundred Thirty Dollars payable November 15th 1908, and a like sum payable on the 15th day of November each year during the term of this contract.

It is understood and agreed that the party of the second part shall have the privilege of removing any building which he may erect on said premises.

It is understood and agreed that when fences need repair, party of the first part shall furnish the material and the party of the second part shall perform the labor in making the repairs.
