COMPARED ASSIGNMENT OF LEASE.

Harnage all of my right, title and interest in certain agricultural lease on the NE¹/₄ of the 7124th Section E4, Township 19 Nth, Range 12 East, the same being the homestead allotment of Joe H. Tiger, a citizen of the Creek Nation, and said lease being dated the 10th, day of February, 1908.

Said lease being recorded in the office of the Register of Deeds at Tulsa, Oklahoma in Record 15, at page 415, on the 10th, day of February, 1908.

And ^{which said} lease was duly signed by the lessee ^{said} E. H. Oglesby to J. L.
