IN THE COUNTY COURT OF MCINTOSH COUNTY AND STATE OF OKLAHOMA.

IN THE MATTER OF THE GUARDIANSHIP OF BETTIE DEPRIEST, A MINOR, LEVI CHILDERS, GUARDIAN
ORDER CONFIRMING AND APPROVING GUARDIAN'S LEASE OF WARD'S LAND FOR OIL AND GAS.

On this day Levi Childers, guardian herein, presents for confirmation and approval an oil and gas mining lease executed in triplicate on the 5th, day of October, A. D. 1908, with G. T. Braden of Pittsburg, Pa., lessee, for a term extending from the 5th, day of October 1908 to the 4th, day of November A. D., 1912, and so long thereafter as oil or gas is produced therefrom, covering the lands of his ward, Bettie Depriest, in Tulsa County, and State of Oklahoma described as follows, to wit:

The West Half of the South East quarter, and the South East Quarter of the South West quarter, of Section Twenty four (24) Township Seventeen (17) North, Range Thirteen (13) East, containing One Hundred and Twenty Acres, more or less. Pursuant to an order made on the 5th, day of October, A. D. 1908, by this court.

And having examined the lease and heard the evidence upon the same, and it appearing that the guardian is receiving a bonus of Two Hundred and Seventy Dollars and Fifty Cents (\$207.50) for said lease and that said bonus is the best that could be obtained, and it further appearing that the lessee herein is a reliable and responsible person; and it further appearing that said lease is for the best interest of the said ward's estate and is in proper form and covers only the period of the said ward's minority, and being well and sufficiently advised in the premises:

It is ordered that said lease be and the same is hereby ratified, approved and confirmed and that a certified copy of this ^{order} ~~order~~ be attached to each of the three parts of said lease here and now presented for approval, and that one part thereof with such certified copy attached be returned to the said guardian Levi Childers, one part with a certified copy attached be delivered to the lessee G. T. Braden of Pittsburg, Pa. The triplicate part to remain on file in this court with the papers in the case
