now are, the usual wear inavoidable accidents and loss by fire excepted, and will not make or suffer any waste thereof, nor lease, nor underlet, nor permit any other person or persons to occupy the same or make or suffer to be made, any alteration without the consent of said party of the first part in writing having first ebtained; and not use or occupy said premises for any business or thing deemed extra hazaradous on account of fire and upon the voilation or default inany of the preceding covenants and provisions or the non-payment of the rent as aforesaid, the said party may at his election ; declare this lease at an end, and recover the possession of said premises as if held by forcible detainer , the said party of the second part hereby waiving any # notice of such election, or any notice or demand for the possession of said premises .

The covenants herein shall extend to and be binding upon the heirs, executors and administrators of the parties to this lease .
