

IN THE COUNTY COURT OF MCINTOSH COUNTY OKLAHOMA

IN THE MATTER OF THE GUARDIANSHIP OF LEE WOLF, A MINOR, WM. P. MORTON GUARDIAN) ASSIGNMENT OF
DOWER.

KNOW ALL MEN BY THESE PRESENTS: That Roley Wolf, in his life time, and at the time of his death on the 18th, day of December, 1906 was seized in fee of the following described real estate to wit

The North East Quarter of the North West Quarter of Section Thirty Four, and The North Half and the South East Quarter of the South West Quarter of Section Ten, all in Township Eighteen North, Range Twelve East, and in what is now Tulsa County, State of Oklahoma, containing one Hundred and Sixty acres.

Which upon his death descended to Lee Wolf, his son and only heir at law.

That Lovina Wolfe, now Lovina Deere, is the widow of the said Roley Wolfe.

That Wm. P. Morton is the duly appointed/ qualified and acting guardian of the person and estate of Lee Wolfe, the minor son of Roley Wolfe, aforesaid.

That said Lee Wolfe, through and by his guardian Wm. P. Morton aforesaid, and in pursuance of the law in force in the Indian Territory, at the time of the death of Roley Wolfe deceased, hereby assign, endows, and sets over unto the said Lovina Deere, formerly Lovina Wolfe the one third part of said real estate/ as follows to wit:

The North East Quarter of the North West Quarter of Section Thirty Four, and the South East Quarter of the Southeast Quarter of the South West Quarter and the East one third of the South West Quarter of the South East Quarter of the South West Quarter of Section Ten, all in Township Eighteen North, Range Twelve East, in Tulsa County Oklahoma, and containing Fifty Two and one third acres/

The said Lovina Deere, formerly Lovina Wolfe, shall have and hold the said premises during her natural life as dower and as recompense and satisfaction of dower, which the said Lovina Deere ought to have an said real estate.
