That party of the first part in consideration of the payment to John Harry of \$ 2 5.00 in cash in hand by party of the second part, the receipt of which is hereby acknowledged and of the agreements of party of the second part and the prompt performance o of said agreements as hereinafter set out by these presents do lease for agricultural purposes, lease to party of the second part for a term beginning Sept 8 1908 and ending Sept 8 th 1913 the following lands and tenements lying and being in the County of Tulsa, State of Oklahoma .

The S E I/4 of S W I/4 of section 5 Twp I9 North Range IO East . and upon the following terms :

This lease shall not be as signable without the consent of party of the first part and the party of the second part shall ghave the right to sublet without the consent of the **first** party of the first part .
