SHERIFF'S DEED.

KNOW ALL MEN BY THESE PRESENTS: That Whereas, at the June Term, 1908, of the District Court of the Twenty) first Judicial District of the State of Oklahoma, sitting inand for the county of Tulsa in the State of Oklahoma, and on the 23rd, day of June, 1908, in an action then pending in said Court, wherein J. W. Pickett was Plaintiff and R. G. O'Hair and Maud O'Hair, Zona O'Hair, Lola O O'Hair, Orville O'Hair and Harry O'Hair, minors, and heirs at law of Maggie O'Hair, deceased, and J. E. Hendon were defendants, said plaintiff racovered a judgement in said Court against said defendants R. G. O'Hair for the sum of Four Hundred and Eighty-Six Dollars and Nine Cents (\$486.09) and \$______ costs of said action, and that said judgement for \$486.09 bear interest at the rate of eight per cent per annum from the date of the rendition thereof.

And WHEREAS, on said day in said cause, it was further considered, ordered and adjudged, and a further judgement was rendered against all of said defendants, that the property foreclosed in said action be-foreclosed in said action to be sold by the Sheriff of Tulsa County, State of Oklahoma, according to law with appraisement, and that the proceeds of said sale be applied first in satisfaction of the costs therein, and then to payment of Plaintiff's claim, and the balance, if any there be, be brought into court.

AND WHEREAS, on the 7th, day of July, 1908, there was issued out of the Clerk's office of the said Court an order of sale on said Judgement in said action, directing to the Sheriff of the County of Tulsa, and dated the 7th, day of July, 1908, reciting the aforesaid Judgement of said Court, as hereinbefore set out, and cormanding said Sheriff to proceed according to law to advertise and sell with appraisement the aforesaid lands and tenements and apply the proceeds as directed by said judgement as aforesaid, which said order of sale afterwards on the 7th, day of July, 1908, came into the hands of Lon Lewis, Sheriff of Tulsa County, Oklahoma, to be executed, and , whereas, on the 17th, day of August, 1908, at I.0.00 A. M. of said day and at the front door of the Cou t House in the City of Tulsa, in the County-of Tulsa, and State of Oklahoma, said Sheriff having first given notice of the time and place of said sale, more than thirty days prior to said day, by advertisement rublished in the "Tulsa Chief", a weekly newspaper printed in the City of Tulsa and of general circulation in said County of Tulsa, and by placing a copy or the Court House Door, and by posting a copy in five other public places in said County, sold said lands and tenements with appraisement to J. W. Pickett, for the sum of Three Hundred Seventy five Dollars (\$375.00) being more than two thirds of the appraised value he being the highest and best bidder therefor:

AND WHEREAS, afterward on the first day of September, 1908, said order of sale, with the proceedings of the said Sheriff thereunder were returned into said court, and afterwards, and on the fifth day of October, A. D., 1908, at the October term A.
