CONTRACT FOR SALE OF LAND.

THIS AGREEMENT, Made this 16, day of November, 1908, between Amelia Harrison, nee Thomas of Muskogee County of Muskogee, State of Oklahoma, party of the first part and W. T. Brambaugh of Broken Arrow, County of Tulsa, State of Oklahoma.

WITNESSETH: That the party of the first part, for and in consideration of the sum of One & no/100 Dollars, to him in hand paid (or, to be paid as hereinafter mentioned) has contracted and agreed to sell to the said party of the second part, the following described real estate, to wit:

South East Quarter of South West Quarter of Section Eleven, Township Nineteen, Range Thirteen E., containing 40 acres, being the Homestead allotment of said Amelia Harrison, nee Thomas said land situated in Tulsa Co. Oklahoma. It is further agreed that the husband of first party will join in signing deed to said land to second party.

And the said party of the first part agrees to deliver to the said party of the second part, a good and sufficient warranty deed, therein giving possession at once, for said land; PROVIDED, That the party of the second part, his heirs and assigns, pay to the party of the first part, his heirs or assigns for said land, the sum of Nine Hundred & no/100 Dollars, payable as follows: The sum of \$1.00 on signing this agreement, the sum of \$899 less the amount of one mtg. for \$325 and the taxes now due, on delivery of this deed, which is to be at the office
