This agreement made and entered into on this 9th day of Sept 1908 by and between J.H. Rogers and L.D. Ladd of Tulsa Okla parties of the first part and M.A. Younkman of Tulsa Okla, party of the second part:

WITNESSETH: That whereas first parties are the owners of a one (1/2) half undivided interest in one certain oil and gas lease under the terms of a certain agreements executed on the 28th day of July 1908 by Harry Tyrell and W.F. Edwards in favor of first parties, which agreement is attached hereto and made a part of this contract said oil and gas lease is upon the following described land situated in Tulsa County Oklahoma, to-wit :-

The Northwest 9.47 acres of lot Two (2) and the southeast ten (10) acres of lot Two (2) of section Five (5) and the east half of Lot Two (2) of Section Six (6) ~~of section Five (5) and the east half of Lot Two (2) of Section Six (6)~~ all in Township Twenty (20) North of range thirteen (13) east in Tulsa County State of Oklahoma, containing forty acres more or less.

Now, therefore, for and in consideration of the sum of \$1.00 and other valuable considerations, the receipt of which is hereby acknowledged, the parties of the first part hereby assign, transfer and deliver to the parties of the second part a one fourth (1/4) interest of all their right, title and interest in and to said oil and gas lease under the terms and conditions of said agreements executed on the 28th day of July 1908 above referred to and made a part hereof.

This agreement to be binding upon the heirs, executors and assigns of the parties hereto.
