

A lease executed by Willie Girtle on the 17th day of November 1904 covering the southeast quarter of North east quarter; southwest quarter of North east quarter ; southeast quarter of Northeast quarter of Northeast quarter of Section 13 Township 25 North Range 13 East & containing 90 acres more or less, the same being designated upon the records of the United States Indian Agent at Muskogee, Oklahoma, as lease No 2519.

A lease executed by E.J. Goodman on the 29th day of March 1905 covering the southwest quarter of North west quarter ; west half of southeast quarter of Northwest quarter of Section 24, Township 29, North Range 13 East , containing 60 acres more or less, the same being designated upon the records of the United States Indian Agent at Muskogee Oklahoma, as Lease No 33 18 .

A lease executed by A.C. Holmes on the 4th day of November 1904 covering the southwest 10 acres of Lot 4 of Section 1 Township 28 North, Range 13 East, containing 10 acres , more or less, the same being designated upon the records of the United States Indian Agent at Muskogee Oklahoma, as Lease No 2517.

A lease executed by William Humansticker on the 29th day of October 1904 covering Lot 2 of Section 15 Township 29 North Range 13 East containing 33.05 acres more or less, the same being designated upon the records of the United States Indian Agent at Muskogee Oklahoma, as Lease No 25 08.

A lease executed by Eliza Jackson on the 24th day of October 1904 covering the south half of southeast quarter of section 33, Township 29 North, Range 13 East; North 19.72 acres of Lot 3; southwest 10 acres of Lot 3; all of Lot 4 ~~Northwest quarter~~ Northwest quarter of Northwest quarter of southwest quarter of Section 2 Township 28 North, Range 13 East, containing 159.36 acres, more or less, the same being designated upon the records of the United States Indian Agent at Muskogee Oklahoma, as Lease No 1276.

A lease executed by John Ketcher on the 5th day of November 1904 covering the southeast quarter of Southwest quarter; southeast quarter of Northeast quarter of southwest quarter of Section 17/ Township 23 North, Range 14 East, containing 50 acres, more or less, the same being designated upon the records of the United States Indian Agent at Muskogee Oklahoma, as Lease No 2513.

A lease executed by Berry H Ladd, guardian of Essie N Ladd , a minor, on the 5th day of November 1904, to continue until the 10 th day of October 1917, covering the southeast quarter of Northwest quarter; south half of Northeast quarter of Northwest quarter of Section 30 Township 29, North Range 14 East containing 60 acres, more or less, the same being designated upon the record of the United States Indian Agent at Muskogee Oklahoma, as lease No 1289.

A lease executed by Nettie Ladd on the 1st day of November 1904 covering the southwest quarter of Northeast quarter;; south half of Northwest quarter of Northeast quarter of Section 30, Township 29 North, Range 14 East , containing 60 acres more or less, the same being designated upon the records of the United States Indian Agent at Muskogee Oklahoma, as lease No 1279.

A lease executed by Berry H Ladd guardian of Percy H Ladd, a minor on the 5th day of November 1904, covering the Northwest quarter of southeast quarter; north half of southwest quarter of southeast quarter of Section 30 Township 29 North, Range 14 east containing 60 acres more or less the same being designated upon the records of the United
