

Indian Agent at Muskogee Oklahoma, as lease No I290

A lease executed by Berry H Ladd guaridan of Roy Ladd, a minor on the 11th day of March 1905, to continue until the 15th day of September 1918, covering the southeast quarter of southwest quarter; east 20 acres of Lot 4; ~~Southwest quarter~~ 9.84 acres of Lot 4 of Section 30, Township 29 North, Range 14 East containing 69.84 acres, more or less, the same being designated upon the records of the United States Indian Agent at Muskogee Oklahoma, as lease No I291,

A lease executed by William Miller on the 30th day of September 1904 covering the North 20.21 acres of Lot 3 Section 1, North 20.01 acres of Lot 4 Section 1, Northeast 9.95 acres of Lot 1 Section 2 Township 28 North Range 13 East, containing 50.17 acres more or less, the same being designated upon the records of the United States Indian Agent at Muskogee Oklahoma, as lease No. I255.

A lease executed by John Parks on the 11th day of November 1904 covering the southeast quarter of North east quarter of Southwest quarter; southeast quarter of southwest quarter of Section 33 Township 29 North, Range 13 East; North 19.46 acres of Lot 2 and Southwest 10 acres of Lot 2, of Section 3 Township 28 North Range 13 East, containing 79.46 acres more or less, the same being designated upon the records of the United States Indian Agent at Muskogee, Oklahoma, as Lease No 2504.

A lease executed by Charles Reese on the 15th day of September 1904 covering the Northwest quarter of Northeast quarter; North half of Southwest quarter of Northeast quarter of Section 31, Township 29 North, Range 14 East, containing 60 acres, more or less the same being ^{designated} designated upon the records of the United States Indian Agent at Muskogee Oklahoma, as lease No I282.

A lease executed by Roddy A Reese on the 14th day of September 1904 covering the south half of southeast quarter of Section 19 Township 29 North, Range 14 East, containing 80 acres more or less, the same being designated upon the records of the United States Indian Agent at Muskogee, Oklahoma, as lease No I284.

A lease executed by Rora Reese on the 28th day of September 1904 covering the south half of Northwest quarter of Section 36 Township 29 North Range 13 East, containing 80 acres more or less, the same being designated upon the records of the United States Indian Agent at Muskogee Oklahoma, as Lease No I281.

A lease executed by Sarah Tickangky on the 7th day of November 1904 covering the North half of Northeast quarter of southwest quarter; southwest quarter of Northeast quarter of southwest quarter of section 17; east half of Northeast quarter of northwest quarter; Northwest quarter of Northeast quarter of Northwest quarter of Section 20/ Township 23 North Range 14 East, containing 60 acres, more or less, the same being designated upon the records of the United States Indian Agent at Muskogee, Oklahoma, as lease No 2520.

A lease executed by John R Vann on the 31st day of October 1904 covering the Northeast quarter of Northeast quarter of Northeast quarter; south half of Northeast quarter of Northeast quarter; North half of southeast quarter of North east quarter of section 27/ Township 25 North, Range 13 East; Lot 4 containing 6.29 acres of Section 14, township 23 North Range 12 east, containing 56.29 acres, more or less, the same being designated upon the records of the United States Indian Agent at Muskogee Oklahoma, as lease No 2524.
