THIS INDENTURE Made this I7 th day of September 1908 by and between Emily M Campbell of Tulsa Tulsa County, State of Oklahoma, executrix of the last will and testament of Wilbur Emory Campbelll, decease, of the first part, and E.W. Potee of Tulsa Tulas County, State of Oklahoma, of the second part :

WITNESSETH: That whereas under the berms of the said last will and testament of the said Wilbur Emory Campbell, decedent, said will having been admitted to probate in the County Court of the County of Tulsa, State of Oklahoma, on the IOth day of December I907 power was given to the said executrix, Emily M Campbell to dispose of in such manner as seemed to her fitfing any and all real estate decedent died seized of, and to sell and convey the same by good and sufficient warranty deeds, and;
