The court further finds that on the IIth day of September I908 the petiti ner Lizzie Seber nee Cloud made, executed and delivered to one Charles Page, a Warranty Deed conveying said land to the said Page that the consideration mentioned in said deed, to-wit \$ 800.00 is adequate and reasonable.

It is therefore by this Court considered ordered, adjustged and decreed that the said deed presented herewith be and the same is hereby approved according to Section 9 and Act of Congress. approved May 27 1908, entitled "An act for theremoval of restrictions from part of the lands of allottees of the Five Civilized Tribes and for other purposes "
