

The south one-half of North-east one -fourth of the southeast one-fourth of Section 4 and the south-east one-fourth of the south-east one-fourth of Section 4 and West one-half of south-west one fourth of south-west one fourth of Section 3 and the East one half of the North west one fourth of Section 12 all in Township 19 North, Range II East .

That the said Miley Cloud died inte .state on or about the 10th day of June 1899 leaving as her sole and only heir at law the said Lizzie Seber, nee Cloud, her mother, leaving no father nor brothers, nor sisters; and that the said Lizzie Seber nee Cloud is of full and legal age; that there has been no issue born to the said Miley Cloud since the 4th day of March 1906, who was a resident of what is now Tulsa County at the date of his death .

The court further finds that on the 11th day of September 1908 the petitioner Lizzie Seber nee Cloud made, executed and delivered to one Charles Page, a Warranty Deed conveying said land to the said Page that the consideration mentioned in said deed, to-wit \$ 800.00 is adequate and reasonable .

It is therefore by this Court considered ordered , adjudged and decreed that the said deed presented herewith be and the same is hereby approved according to Section 9 of an Act of Congress approved May 27 1908 , entitled " An act for the removal of restrictions from part of the lands of allottees of the Five Civilized Tribes and for other purposes "

----- : OIL AND GAS LEASE :-----

This agreement made this 2nd day of September A.D. 1908 by and e between Sallie Murphy of Tahlequah Oklahoma of the first part, and The Iron Mountain Oil Company of Lima Ohio of the second part,

WITNESSETH: That the said party of the first part, for One Dollar and other good and valuable considerations, the receipt whereof is hereby acknowledged, and in further considerations of the covenants and agreements hereinafter mentioned (has granted), demised, leased and let unto the party of the second part, its successors , heirs and assigns all of the oil and gas in and under that certain tract of land hereinafter described; and ^{also} the said tract of land for the purpose and with the exclusive right of drilling and operating for said oil and gas; which said tract of land is situated in the County of Tulsa ^{State} of Oklahoma and described as follows, to-wit :-

The southwest quarter (1/4) of the southeast quarter (1/4) and the southeast quarter (1/4) of the southwest quarter (1/4) of Section Twenty Nine (29)
