Know all men by these presents : That , whereas, on the 2nd day of September 1907 a certain Deed of Trust was made and entered into by and between Mary Williams Barber, nee, Williams and John W Barber , her husband, of Broken Arrow, Oklahoma, (I.T.) parties of the first part, and C.F. Lynde of Muskogee Okla (I.T) party of the second part , and Lynde-Bowman- Darby Company , a corporation, party of the third part, covering the following described land, to-wit :-

The south half (1/2) of the Southeast quarter (1/4) of Section Thirty one (31) Township Nineteen (19) North Range Fifteen (15) East, and the Northeast quarter 1/4 of the southwest quarter (1/4) of section One (1) Township eighteen (18) North, ^{Range fourteen (14) east of the Indian Base line} containing 120 acres, more or less , and

WHEREAS, Said deed of Trust was executed and delivered to C.F. Lynde, Trustee, to secure an indebtedness in the sum of Fifteen Hundred (\$ 1500.00) Dollars, with interest and ^{charges} ~~charges~~ from the parties of the first part to the party of the third part, and

WHEREAS, said Deed of Trust was filed for record Sept 11, at 8 0 ' Clock A.M., 1907 in the office of the Clerk of the U. S. Court at Wagoner I.T. (Okla) and duly recorded in Vol 44 Page 372 which said records have since been transferred to the register of Deeds of Wagoner County, Oklahoma , and

WHEREAS, said deed of Trust was again filed for record Sept 27 at 8 0 ' Clock A.M. 1907 in the office of the Clerk of the U.S. Court at Tulsa I.T. (Okla) and duly recorded in Vol 17 page 544, which said records have since been transferred to the Register of Deeds of Tulsa County, Oklahoma .

NOW Therefore for and in consideration of the said sum of Fifteen ^{of} \$ 1500.00 ^{to said party of the second part for said party of the third part} Dollars with interest and charges to date, in hand paid, the receipt of which is hereby acknowledged, the party of the second part and the party of the third part hereby release, relinquish, quitclaim and set over unto the said party of the first part, all the right, title and interest they have, or either of them has, in and to the above described land under and by virtue of said deed of Trust with the intent and purposes of discharging said incumbrance, and hereby acknowledged satisfaction in full of said indebtedness .
