This Indenture, Made this 15th day of December in the year of our Lord One Thousand Nine Hundred and Eight by and between Martha E. Smith and her husband, J. M. Smith, of the County of Tulsa and State of Oklahoma, part of the first part and Lee Clinton part of the second part.

WITNESSETH, That the said part of the first part, for and in consideration of the sum of Five hundred & twenty nine Dollars, to them in hand paid, by the said party of the second part, the receipt whereof is hereby acknowledged, have granted, bargained and sold, and by these presents do grant, bargain, sell, convey and confirm, unto said part of the second part, and to his heirs and assigns, forever, all of the following described tract, piece or parcel of land lying and situate in the County of Tulsa and State of Oklahoma, to-wit:

all that part of lot two (2) in block one hundred ninety nine (199) in the original town of Tulsa (C.D.) Chd. commencing at a point 2.03 feet southeast on line of South Detroit ave. from the northwesterly corner of block 199. Thence 43 feet southeasterly with the east line of said South Detroit ave. to a stake. Thence at right angle northeasterly the east line of said block 199. Thence north on east line of said block 15 feet more or less. Thence southeasterly to the place of beginning. The main body of the tract of land described to be 43 feet wide at all points excepting where line is not run at right angle at east end of this tract.

TO HAVE AND TO HOLD THE SAME, With all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and all rights of homestead exemption, unto the said part of the second part, and to his heirs and assigns forever. And the said part of the first part do hereby covenant and agree that at the delivery hereof they are the lawful owners of the premises above granted, and seized of a good and indefeasible estate of inheritance therein free and clear of all incumbrances, and that they will warrant and defend the same in the quiet and peaceable possession of said Lee Clinton of the second part.

PROVIDED ALWAYS, And this instrument is made, executed and delivered upon the following conditions to-wit:

FIRST: Said Martha E. Smith, J. M. Smith her husband are justly indebted unto the said part of the second part in the principal sum of Five hundred & twenty nine Dollars, in gold coin of the United States of the present standard of weight and fineness, being for a loan thereof made by the said part of the second part, to the said part of the first part, and payable according to the tenor and effect of certain negotiable promissory note, numbered 1025, executed and delivered by the said part of the first part, bearing date Dec 15, 1925, payable to the order of said Lee Clinton, 6 months, years after date, at Tulsa, Okla. with interest thereon from date until maturity, at the rate of 10 per cent per annum, payable semi-annually on the day of and in each year, and per cent per annum after maturity, the installments of interest being further evidenced by coupons attached to said principal note and of even date therewith and payable to the order of said Lee Clinton.

SECOND: Said part of the first part agree to pay all taxes and assessments on said lands and premises when the same are due, and to keep all buildings and improvements on said land insured in some responsible fire insurance company, to the satisfaction of the holder hereof in the sum of One thousand Dollars, the policy to be made payable to the holder hereof, as additional security to this loan and if the taxes or insurance premiums are not paid when due, by the part of the first part, the holder hereof may pay the same, and this mortgage shall be security also for such payments, with interest thereon at the rate of 12 per cent per annum and the first part assume all responsibility of proofs and care and expense of collecting said insurance if loss occurs.

THIRD: The said part of the first part agree to keep all buildings, fences and improvements on said land in as good repair as they now are, and to commit or allow any waste on said premises.

FOURTH: In case of default in any of the covenants hereof, the rents and profits of the said premises are pledged to the holder hereof as additional collateral security for the payment of the moneys herein mentioned, and the holder is entitled to the possession thereof by receiver or otherwise.

FIFTH: Said part of the first part agree that if the maker of said note shall fail to pay the principal or interest of said note or any part thereof at the same become due or any of the taxes, assessments or insurance premiums, as they become due or to comply with any of the foregoing covenants, the whole sum of money hereby secured shall at the option of the holder hereof become due and payable at once, and without notice.

The said part of the first part, shall pay all expenses of collecting the insurance, and in the event action is brought to foreclose this mortgage or recover on

insurance policy, a reasonable attorney's fee of not less than Twenty five Dollars shall be added, which this mortgage also secures.

And that the said part of the first part, for said consideration, do hereby expressly waive an appraisal of said real estate and all benefit of the homestead exemption and stay laws of the State of Oklahoma.

The foregoing conditions being performed, this conveyance to be void, otherwise of full force and virtue.
