WITNESSETH, that the said part 1st of the first part, in consideration of the sum of Seven hundred and thirteen and 00/100 Dollars, to her duly paid, the receipt of which is hereby acknowledged, has she sold, and by these presents do she Grant, Bargain, Sell and Mortgage to the said party of the second part or assigns forever, all that tract or parcel of land situated in the County of Tulsa in the State of Oklahoma, described as follows, to-wit:
