THIS INDENTURE, Made this 17 day of February A. D., 1907, between J. E. Preister of Indian, Ind. Ter. and Lollie Preister his wife, and W. E. Hutchings of Indian, Ind. Ter. witnesseth, that

WHEREAS, the said J. E. Preister and Lollie Preister are justly indebted to the said W. E. Hutchings in the sum of Three Hundred no/100 DOLLARS (\$300.00) which is evidenced by one certain promissory note of even date herewith, to-wit:

One note due August-17, 1907, for \$300.00; one note due 1907, for \$300.00
One note due 1907, for \$300.00; and one note due 1907, for \$300.00

NOW, THEREFORE, the said J. E. Preister and Lollie Preister his wife, for the better securing the payment of the money aforesaid, with interest thereon according to the tenor and effect of said note above mentioned, do hereby grant, bargain, sell and convey unto the said W. E. Hutchings His heirs and assigns forever, the following described real estate, to-wit:

Lot One and Two (1 & 2) Block Eight (8) in West Tulsa, I. T. and according to the "Official Plat" thereof.

with all the improvements thereon at the present time, or that hereafter may be placed thereon, together with all the privileges and appurtenances thereto belonging.

TO HAVE AND TO HOLD the above granted, bargained, and described premises unto the said W. E. Hutchings His heirs and assigns unto His own proper use, benefit and behoof forever.

AND WHEREAS, For the further security of said indebtedness, the said parties of the first part, covenant and agree with the said party of the second part, to keep the improvements on the said property at all times in a state of good repair and constantly insured for the benefit of the said party of the second part, his heirs and assigns in one or more insurance companies satisfactory to the said party of the second part, against fire, lightning or tornadoes. Should the party of the first part make default in the performance of any of these stipulations, the said party of the second part may immediately perform and discharge the same, and all accounts so expended by the said party of the second part, heirs or assigns, in paying said taxes, insurance premiums, loans or special assessments or in protecting said title, or making said repairs, shall become a debt due in addition to the indebtedness aforesaid, and secured in like manner by this mortgage, and shall bear interest from the time of the payment thereof at the rate of eight per cent per annum payable on demand.

And for the consideration aforesaid, and for divers other good and valuable considerations, I, Lollie Preister wife of said J. E. Preister do hereby release and quit-claim unto the said W. E. Hutchings His heirs and assigns, all my right, claim or possibility of dower in and out of the aforescribed premises

CONDITIONED, However, that if the said J. E. Preister and Lollie Preister their heirs, executors, or administrators, shall well and truly pay or cause to be paid to the said W. E. Hutchings His executors, administrators, or assigns, the aforesaid sum of money, with interest thereon, according to the tenor of said note, then this instrument shall be void otherwise to remain in full force and effect.
