

MORTGAGE OF REAL PROPERTY.

THIS INDENTURE, Made this 19th day of April, A. D., 1907, between W. H. Brown of Lumber Co. and Alice E. Brown, his wife, and Brimson Patterson, witnesseth, that

WHEREAS, the said W. H. Brown and Alice E. Brown is justly indebted to the said Brimson Patterson Lumber Co. in the sum of Two Hundred Seventy Six and 1/100 DOLLARS, (\$ 276.10) which is evidence by 3 certain promissory note of even date herewith, to-wit:

One note due July 1st, 1907, for \$ 76.56; one note due Sept 1st, 1907, for \$ 100.00
One note due Dec 1st, 1907, for \$ 100.00, and one note due 190 for \$

NOW, THEREFORE, the said W. H. Brown and Alice E. Brown his wife, for the better securing the payment of the money aforesaid, with interest thereon according to the tenor and effect of said note above mentioned, do hereby grant, bargain, sell and convey unto the said Brimson Patterson Lumber Co. heirs and assigns forever, the following described real estate, to-wit:

Lot (X 5) Five in Block (X 4) of Grandview addition to the City of Tulsa, Western District, Indian Territory, subject to a prior mortgage of \$460. held by W. E. Demarey and \$80 held by Krumm Investment Co.

with all the improvements thereon at the present time, or that hereafter may be placed thereon, together with all the privileges and appurtenances thereto belonging.

TO HAVE AND TO HOLD the above granted, bargained, and described premises unto the said Brimson Patterson Lumber Co. heirs and assigns and unto its own proper use, benefit and behoof forever.

AND WHEREAS, For the further security of said indebtedness, the said part of the first part, covenant and agree with the said part of the second part, to keep the improvements on the said property at all times in a state of good repair and constantly insured for the benefit of the said part of the second part, heirs and assigns in one or more insurance companies satisfactory to the said part of the second part, against fire lightning or tornadoes. Should the part of the first part make default in the performance of any of these stipulations, the said part of the second part may immediately perform and discharge the same, and all accounts so expended by the said part of the second part, heirs or assigns, in paying said taxes, insurance premiums, liens or special assessments or in protecting said title, or making said repairs, shall become a debt due in addition to the indebtedness aforesaid, and secured in like manner by this mortgage, and shall bear interest from the time of the payment thereof at the rate of eight per cent per annum payable on demand.

And for the consideration aforesaid, and for divers other good and valuable considerations, I Alice E. Brown wife of said W. H. Brown do hereby release and quit-claim unto the said Brimson Patterson Lumber Co. heirs and assigns, all my right, claim or possibility of dower in and out of the aforesaid premises.

CONDITIONED, However, that if the said W. H. Brown and Alice E. Brown their heirs, executors, or administrators, shall well and truly pay or cause to be paid to the said Brimson Patterson Lumber Co. heirs, executors, administrators, or assigns, the aforesaid sum of money, with interest thereon, according to the tenor of said note then this instrument shall be void otherwise to remain in full force and effect.
