

# GENERAL WARRANTY DEED

WITH REINFORCEMENT OF POWER

THIS INDENTURE, Made and entered into this 11th day of February, one thousand nine hundred and five,  
by and between S. M. Allen,  
Archibald Arrow, Jr. part of the first part, and Krausk Heckenlively  
of Broken Arrow, Jr. part of the second part;

WITNESSETH, That that the said part of the first part, for and in consideration of the sum of Three Hundred Dollars (\$300.)  
DOLLARS, in hand paid, the receipt of which is hereby acknowledged,  
do hereby grant, bargain, sell, convey and confirm unto the said part of the second part the following described real estate and premises situated in the

Muskogee or Creek Nation, and within the limits of the Indian Territory, to wit:

Lots six (6) and seven (7) in Block fifteen (15) in the Town of Broken Arrow, Jr.

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining thereto

To have and to hold the aforesigned premises to the said Krausk Heckenlively  
and his heirs and successors, in fee simple forever; and I the said S. M. Allen  
for myself and my heirs, executors and administrators do covenant with the said Krausk Heckenlively  
and his heirs, successors and assigns, that I am lawfully seized in fee of the aforesigned premises; that  
they are free from all incumbrances and that I have good right to sell and convey the same to said  
Krausk Heckenlively as aforesaid; and that I will and my successors, heirs, executors and administrators shall warrant and defend the same to the said Krausk Heckenlively  
and his heirs, successors and assigns forever against the lawful claims and demands of all persons.

And I, Harriet S. Allen, wife of said S. M. Allen, for and in consideration of the said sum of money, do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to the said lands.
