**THIS INDENTURE**, Made and entered into this 28 day of March, one thousand nine hundred and seven, by and between Randy Grummeth and Sophia Grummeth, his wife, of the first part, and James M. Arthur of the second part;

WITNESSETH, That that the said part, of the first part, for and in consideration of the sum of Eight Hundred & no 100 DOLLARS, in hand paid, the receipt of which is hereby acknowledged,

do hereby grant, bargain, sell, convey and confirm unto the said part, of the second part the following described real estate and premises situated in the Cherokee Muskogee or Creek Nation, and within the limits of the Indian Territory, to-wit: The Northwest fourth (44) of the North west quarter (44) Section thirty five (35) and the south half (½) of the south east fourth (44) of the north east quarter (44) and the north west fourth (44) of the Southwest fourth (44) of the Northwest fourth (44) of the North east quarter (44) and the Southwest fourth (44) of the North east quarter (44) of the North east quarter (44) Section thirty four (34) all in Township Sixty two (62) North Range Thirteen (13) East.

together with all the improvements thereon, and the appurteances and immunities thereon belonging or in any wise appertaining thereto.

To have and to hold the aforesigned premises to the said James M. Arthur and his heirs and successors, in fee simple forever; and the said Randy Grummeth and Sophia Grummeth for and their heirs, executors and administrators do covenant with the said James M. Arthur and his heirs, successors and assigns, that they lawfully seized in fee of the aforesigned premises; that

they are free from all incumbrance; that they have good right to sell and convey the same to said

James M. Arthur as aforesaid; and that he will and his successors, heirs, executors and administrators shall warrant and defend the same to the said James M. Arthur

and his heirs, successors and assigns forever against the lawful claims and demands of all persons.

And I, Sophia Grummeth of J. T. Gibson, J. S. wife of said Randy Grummeth, for and in consideration of the said sum of money, do hereby release and relinquish unto the said part, of the second part all my right of dower and homestead in and to the said lands.
