they are free from all incumbrance and that they have good right to sell and convey the same to said

And I, Ada M. Fields of Bovina, Tex.
 the wife of said Thomas R. Fields, for and in consideration of the said sum of money, do hereby re-
 lease and relinquish unto the said part 4 of the second part all my right of dower and homestead in and to the said lands.
