**THIS INDENTURE**, Made and entered into this 5<sup>th</sup> day of December, one thousand nine hundred and six, by and between Mulsaie Bible and Lewis Bible her husband, of the first part, and Joyce Et [initials] of the second part, and E. R. Palmer of the third part.

WITNESSETH, That that the said part of the first part, for and in consideration of the sum of Twelve Hundred DOLLARS, in hand paid, the receipt of which is hereby acknowledged,

do hereby grant, bargain, sell, convey and confirm unto the said part of the second part the following described real estate and premises situated in the Muskogee or Creek Nation, and within the limits of the Indian Territory, to-wit: The south half of the south east (1/4) and the north west (1/4) of the south east (1/4) of section (1/4) to wadship eighteen (18) north Range Thirteen (13) east containing 20 acres more or less according to the United States Government Survey together with all the improvements thereon, and the appurtenances and immunities therein belonging or in any wise appertaining thereto

To have and to hold the aforesigned premises to the said E. R. Palmer and his heirs and successors, in fee simple forever; and me the said Mulsaie Bible and Lewis Bible ourselves and our heirs, executors and administrators do covenant with the said E. R. Palmer and his heirs, successors and assigns, that we are lawfully seized in fee of the aforesigned premises; that they are free from all incumbrance; that we have good right to sell and convey the same to said E. R. Palmer as aforesaid; and that we will and our successors, heirs, executors and administrators shall warrant and defend the same to the said E. R. Palmer and his heirs, successors and assigns forever against the lawful claims and demands of all persons.

And I,                          wife of said, for and in consideration of the said sum of money, do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to the said lands.
