WITH RELINQUISHMENT OF DOWER

THIS INDENTURE, Made and entered into this 29th day of June, one thousand nine hundred and seven by and between Harkey D. Wellums a single of Muskogee Indian Territory part 4 of the first part, and Laura F. Wellums of part 4 of the second part;

WITNESSETH, That that the said party of the first part, for and in consideration of the sum of Two Hundred and Fifty (\$250.00) DOLLARS, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto the said part 4 of the second part the following described real estate and premises situated in the Muskogee or Creek Nation, and within the limits of the Indian Territory, to-wit: Lots numbers one (1) Two (2) Three (3) Four (4) in Block number six (6) in Barnett Addition to the town of Skiatook, Indian Territory according to the plat and survey thereof, each lot being 25 feet frontage by 140 feet deep)

together with all the improvements thereon, and the appurtenances and immunities thereon to be'onging or in anywise appertaining thereto To have and to hold the aforegranted premises to the said Laura F. Wellums and her heirs and successors, in fee simple forever; and I the said Harkey D. Wellums together for myself and my heirs, executors and administrators do covenant with the said Laura F. Wellums and her heirs, successors and assigns, that I am lawfully seized in fee of the aforegranted premises; that they are free from all incumbrances; that I have good right to sell and convey the same to said Laura F. Wellums as aforesaid; and that I will and my successors, heirs, executors and administrators shall warrant and defend the same to the said Laura F. Wellums and her heirs, successors and assigns forever against the lawful claims and demands of all persons, excepting the incumbrances now existing against said property for purchase money

And I, Harkey D. Wellums wife of said Harkey D. Wellums, for and in consideration of the said sum of money, do hereby release and relinquish unto the said part 4 of the second part all my right of dower and homestead in and to the said lands.
